	STATUS	DEFINITION	PROCEDURES
ISOLATION	COVID-19 Positive	Individual who has been laboratory confirmed positive for COVID-19 via Rapid Antigen Test (RAT) or PCR at MTF, where available, or at a certified laboratory w/proof of result.	<ul style="list-style-type: none">Regardless of vaccination status, COVID-19 positive individuals <u>must</u>:<ul style="list-style-type: none">Notify their Chain of Command (COC) or supervisor, (SM/DAC/DEP are notified by Medical Provider if tested on post).Isolate out of workplace for minimum of 5 full days starting from specimen collection date (Day 0).<u>After</u> the minimum 5 days of isolation, individuals can return to <u>all on-post activities</u> if you have no symptoms <u>AND</u> >24 hrs without fever and without using fever reducing meds (with exception of loss of taste/smell, which can take longer to resolve). No testing is required to leave isolation. Individuals leaving isolation <u>must</u> wear at least a cloth mask (recommendation is FFP2/KN95/surgical mask) for 5 additional full days, <u>AND</u> maintain social distance >6 ft from others when possible during this time.Family Members/Dependents will self-release from isolation. SMs/DACs/Contractors/LNs will self -release from isolation with COC/ Supervisor oversight. Individuals leaving isolation <u>must</u> wear at least a cloth mask (recommendation is FFP2/KN95/surgical mask) for 5 additional full days, <u>AND</u> maintain social distance >6 ft from others when possible during this time.
	COVID-19-like Symptoms, but Without Known Exposure	Individual with COVID-19-like symptoms, but without known close contact to a laboratory confirmed COVID-19 positive person.	<p>Regardless of vaccine status or a previous negative result, if new or worsening COVID-19-like symptoms occur:</p> <ul style="list-style-type: none">Notify your COC/supervisor/DoDEA/CYS immediately, <u>AND</u>Test immediately via Rapid Antigen Test or PCR at MTF, where available, or at certified laboratory w/ proof of result, <u>AND</u>Isolate away from others immediately (using your own bedroom and bathroom if possible) until you have received a negative COVID-19 test result and have been medically cleared to return to work/school, etc.<u>Visit the following website for a list of COVID-19-like symptoms:</u> https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html
QUARANTINE	Close Contacts	Individual who meets ALL the following criteria: < 6 feet, <u>AND</u> --Cumulative ≥15 min in any 24 hr period, <u>AND</u> --Exposure occurred within 48 hours prior to COVID positive person's symptom onset (or if asymptomatic, then within 48 hours prior to positive test result sample collection date).	<ul style="list-style-type: none">Regardless of vaccine status, all close contacts must wear at least a cloth mask (recommendation is FFP2/KN95/surgical mask) for minimum of 10 full days from last close contact with positiveRegardless of vaccine status or a previous negative result, if new or worsening COVID-like symptoms occur, immediately test and isolate until negative result received.

	Regionally Aligned Forces (RAF)	Units serving as Regionally Aligned Forces (RAF) arriving from countries or areas identified as High Risk by the Robert Koch Institute (RKI).	- 10 days of quarantine (USAREUR-AF OPORD 0023-21), last 24 hours must be symptom free.	- No ROM required.
	Official Travel (TDY)	Personnel arriving or returning from countries or areas identified as High Risk by the Robert Koch Institute (RKI).	- 10 days of quarantine (USAREUR-AF OPORD 0023-21), last 24 hours must be symptom free.	- No ROM required.
	PCS From Outside Germany	Newly arriving PCS personnel arriving from CONUS.	- 10 days of quarantine (USAREUR-AF TASKORD 21-0011), last 24 hours must be symptom free.	- No ROM required.
	PCS Within Germany	Personnel and their families PCSing from one duty station within Germany to another.	No testing requirement. No quarantine requirement.	- No ROM required.
OTHERS	All Travel Involving an "Area of Variant Concern"	Personnel arriving or returning from any type of travel to countries or areas identified as "Area of Variant Concern" by the Robert Koch Institute (RKI).	- 14 days of quarantine (per Host Nation requirements), last 24 hours must be symptom free. - Must get PCR COVID test and receive test results prior to release.	- 14-day ROM is required per Host Nation requirements, regardless of vaccination status.
	Unofficial Travel	Unofficial Travel is governed by 7th ATC General Order 1 IAW HN Laws.	- Refer to www.7ATC.army.mil/COVID-19for General Order 1 , Annex A to GO1 and corresponding Leisure Travel chart.	

Vaccinated:

Defined as being:

- completion of primary vaccine series

*Up-to-date on Vaccine:

Defined as being:

- ≥ 14 days after completion of primary vaccine series **AND**
- < 6 months from completion of primary mRNA vaccine series, or
- < 2 months from completion of Janssen vaccine, or
- Received a booster vaccine if after this time period.
